**POLL RESULTS OF EXTRAORDINARY GENERAL MEETING
HELD ON 5 MAY 2010**

At the extraordinary general meeting (“EGM”) of CITIC 1616 Holdings Limited (“the Company”) held on 5 May 2010, the ordinary resolution for approving the entry into of the Sale and Purchase Agreement and the transactions contemplated thereunder was duly passed by the Independent Shareholders of the Company by way of poll voting.

Reference is made to the circular of the Company dated 19 April 2010 (“the Circular”) in relation to the acquisition of a 20% interest in Companhia de Telecomunicacoes de Macau, S.A.R.L. Unless the context otherwise requires, terms used in this announcement shall have the same meaning as defined in the Circular.

The board of directors of the Company is pleased to announce that at the EGM of the Company held on 5 May 2010, the ordinary resolution for approving the entry into of the Sale and Purchase Agreement and the transactions contemplated thereunder was duly passed by the Independent Shareholders of the Company by way of poll voting.

As stated in the Circular, CITIC Pacific and its associates were required to abstain from voting at the EGM and they had so abstained from voting.

The poll results taken at the EGM were as follows:-

As more than 50% of the votes were cast in favour of the above resolution, it was duly passed as an ordinary resolution at the EGM.

1. As at the date of the EGM, the total number of issued shares of the Company was 1,977,731,283 shares. The total number of shares entitling the holder to attend and vote for or against the resolution at the EGM was 937,973,000 shares. None of these 937,973,000 shares were the shares entitling the holder to attend and vote only against the resolution at the EGM.
2. Tricor Investor Services Limited acted as scrutineer for the poll at the EGM.
